A message from the President of your Homeowner Association Board, Dianne Lett

Your HOA Board is in the process of preparing for the 2016 Annual Budget. In consideration of The Terraces' current financial status, the Board is happy to report that they have elected NOT to increase the HOA dues for 2016!!! It will remain at \$95. The 2016 Budget, payment notices for assessments, and voting ballets to elect your upcoming 2016 Board members will be sent the first week in December. Payment of assessments is due on December 31, 2015.

Real-Estate Market Overview For Casselberry, 32707 (Quoted from Trulia)

The median sales price for homes in ZIP code 32707 in Casselberry from Aug 15 to Nov 15 was \$168,000 based on 89 sales. Compared to the same period one year ago, the median sales price increased 18.7%, or \$26,500, and the number of sales decreased 42.2%. Average price per square foot for homes in 32707 was \$100, an increase of 12.4% compared to the same period last year. There are currently 127 resale and new homes in ZIP code 32707 on Trulia, including 3 open houses, as well as 203 homes in the pre-foreclosure, auction, or bank-owned stages of the foreclosure process. The average listing price for homes for sale in 32707 was \$185,128 for the week ending Nov 11, which represents an increase of 5.8%, or \$10,129, compared to the prior week. Popular ZIP codes in Casselberry include 32707 and 32730, with average listing prices of \$185,128 and \$134,135.

CRIME WATCH PROGRAM



A Crime Watch Program was presented at our October 13th HOA meeting by Deputy Sheriff Will Stone, Neighborhood Resource Services, Public Affairs Division. Deputy D. Dinnen and Sergeant Mark Stanley also participated. Board members volunteered great refreshments and 12 neighbors attended.

Summary:

• Trends: No huge trends to report. Emphasis was placed on locking car doors while in driveways. Majority of reported burglaries are from cars. Usually kids "car hopping". A few instances reported recently in area. Often garage door openers and keys are left in cars.

Usually crimes are not "forced entries" and usually take place in daytime. No "super scary" instances recently. Phone # to report <u>NON</u>-emergency issues: (407) 665-6650.

- General Information: Seminole County Deputies are assigned to an area or zone, 12-hour shifts for 2 nights and 2 days. There are 35 zones in Seminole County and 7 police departments. 4 deputies are assigned to our area.
- "Nextdoor.com": Provides communication 24 hours a day. It is the future of Neighborhood Watch. "Nextdoor.com" is legitimate. In order to sign on, verification process is required to prove residency in the neighborhood. Seminole County communicates with communities through this media, distributing crime activity and messages of interest. There is NO cost to join, just log on to: www.nextdoor.com/join.
- Miscellaneous: Citizens are encouraged to call the Seminole County Sheriff's Department to report suspicious behavior, no matter how small the circumstances.
