NEW WATERING RESTRICTIONS FOR SEMINOLE COUNTY

Seminole County returns to one (1) day per week landscape irrigation. This restriction is MANDATORY and has been in effect since November 6th, 2016. This restriction includes wells. During the cooler months, less water is needed for a healthy lawn. Residential customers with **ODD** street addresses water on Saturdays with **EVEN** numbered addresses watering on Sundays. No watering is to take place between 10:00 a.m. through 4:00 p.m. any day. However, watering may be done at any time with a hand-held hose provided it is fitted with an automatic shutoff nozzle. If you have newly planted landscaping, your lawn may be irrigated any day between 4:00 p.m. and 10:00 a.m. for the first 30 days following installation. * * * * * * * * * * *
