A message from the HOA Board:

It is with regret that we report that Faith Stanton has resigned as President of The Terraces' Homeowners Association Board. It was a pleasure to have her smiling face on the Board and she will be missed.

Gene Mills, currently Vice President, has agreed to preside over the September 10th meeting. Those remaining Board members have unanimously concurred to nominate Gene for Presidency for the remainder of 2019. The Board and attending guests will vote on his nomination at the September 10th meeting.

A message from the HOA Treasurer, Betty Spanger:

The month of September begins a time when the Board starts preparing next year's budget. Last year's assessment was \$104.00. After reviewing current financial trends, a recommendation will be presented to the Board to vote to increase the HOA assessment by 5% (total \$109.00), or \$5.00, for 2020. According to our Declaration of Covenants, Conditions and Restrictions, the Board is lawfully able to increase up to 5% each year.

This small amount will allow the Board to continue offering current services it provides for our community. It is important to understand that the largest monetary exposure The Terraces has is our front wall. Eventually the wall will require major repairs, and in some places, replacement.

This is caused by tree roots growing that are "uprooting" the wall in places.

We experienced a \$3,000.00 fee for mold removal, priming and painting of the wall in 2017.

This was routine maintenance, but very costly and was not in the budget at that time.

The Board factors a "contingency" amount in our budget to sustain most expenses, but sometimes it is unplanned.

The site of the proposed 384-unit apartment complex is 29.57 acres, mostly located in unincorporated Seminole County. Originally the property was to be developed as a retirement/ assisted living facility owned by Mayflower Retirement Center. They have since sold the property to Jefferson Property Group. The new apartments will be called Jefferson Lake Howell Apartments.

Regarding the Golf Course closing...apparently there has been some "unlawful" construction activity that has taken place on the golf course

property at the clubhouse. By unlawful, it just means that there were no legal permits applied for or issued.

"On July 11, 2019, a building contractor (Seminole State Construction LLC) and an electrical contractor (Seminole State Construction LLC) applied to the county for a building demolition permit and an electrical permit. After review by the county, the two permits were finally issued on July 29, 2019. The golf course owner must still submit to the county for final inspections of the site before the work will be approved and the permits closed. The most current question anyone associated with Save Deer Run has been asked is... 'what's going on at the golf course?' Unfortunately, (or fortunately, perhaps, depending on your perspective) the land's owner, Mr. Robert Dello Russo of the Central Florida Golf Group, still has not submitted an application for permits and building plans that would require the county to approve rezoning. So the answer to that question right now is "not much." However, we continue to expect the owner to submit his plans any day.

Rest assured, if and when these plans are submitted, Save Deer Run will work hard to make sure all residents know as quickly as possible."

Trash is picked up twice a week (Mondays and Thursdays). rake them up and add to your bag of leaves.


It's the right and responsible thing to do.

The following items ARE accepted in the curbside recycling program:

- Pasteboard (i.e., cereal boxes, empty paper towel and toilet paper rolls, soda boxes, beer boxes, tissue boxes, gift boxes, pizza boxes and shoe boxes)
- Brown paper grocery bags (no wax, no wet strength material, no liners)
- Corrugated cardboard (flattened and cut down to fit inside the recycle bin).
- Newspaper, supplements, magazines and catalogs
- Box Board, Carrier Stock, White and Colored Paper
- Plastic Containers #1-7 (#'s on bottom of containers) Remove all lids
- Glass bottles and jars (clear, green and brown) Remove all lids
- Aluminum cans
- · Steel cans and tin household containers, such as food cans
- Telephone Books

Please rinse out all containers and discard lids



- Plastic Bags
- Plastic Cups
- Paper Cups (Wax Lined)
- Paper Plates (Wax Lined)
- Motor oil or pesticide containers
- Light bulbs or drinking glassware
- Aluminum foil or pie plates
- Paint or pesticide cans
- Electronic devices
- Styrofoam trays/egg cartons
