Lawn Clippings

There is no law on how you're supposed to clean up lawn clippings; however, clippings often land in the street and head directly into storm-water basins, creating toxic algae blooms that ultimately end up in our lakes.

Also, keeping our drains clear can help prevent possible flooding due to clogged basins.

All residents should dispose of their grass clippings correctly by placing them in bags or containers. Bags and/or containers cannot weigh more than 50 pounds each.

A total of fifteen (15) containers will be picked up each collection day, in any combination of bags, tied bundles or containers.

Collection day for The Terraces is every Wednesday, with the exception of Christmas Day, New Years' Day, or July 4th if any of these holidays fall on a Wednesday.

MOST IMPORTANT: BE A GOOD NEIGHBOR. DO NOT BLOW YOUR LAWN CLIPPINGS ONTO YOUR NEIGHBOR'S YARD.

Violations

With the New Year comes "New Year's Resolutions." The HOA Board has made a commitment to place emphasis on sprucing up our community. This means that the Violations Committee will be actively in force perusing the neighborhood looking for homes that are not in compliance with our Covenants.

Your HOA Covenants provide guidelines on what constitutes a violation. Violations could include lawns in need of mowing, edging or weeding, unsightly yard debris, construction materials, general maintenance issues, vehicles parked incorrectly, etc. Homes and properties that are neglected affect property values for the rest of us.

· Keep your front yard mowed and edged and replace sod when necessary

• Keep all garbage cans and building materials out of view of the road –except on garbage pick-up dates

• Move all boats / trailers out of your driveway or off the road after three days

• Keep your home in good repair; paint when necessary and remove mold and mildew from view Any home deemed in violation will receive a yellow "Violation Notice." Generally, recipients are

given seven (7) days to rectify the problem. However, in some instances that involve more extensive effort such as painting or re-sodding, etc., the Board will work with you to establish a more responsible timeframe to accomplish the task. It is important to understand that, in the event this problem is not corrected, your HOA DOES have the authority to take legal action.

1. Common Courtesy – What's that smell?

There are many things that can ruin your day, but stepping in a steaming pile is definitely high on the list. When you take your pet off of your property, you are entering public shared space. It is the duty of pet owners to ensure that they pick up after their pets. Your dog's waste is your mess, and you need to pick it up yourself.

2. It's Just Poop, It's Natural, It's Fertilizer - Not True!

A common misconception, or excuse people use, is that poop is natural fertilizer. This is not really true. Not all piles of poop are created equal. Dog fesses are omnivores, and their diets are very high in protein. Dog waste is actually so high in nitrogen and phosphorus that it can have the opposite effect of fertilizer. It can actually burn your lawn if you don't pick it up.

3. Disease Causing Bacteria and Parasites – Harmful For Humans And Dogs

Nitrogen and phosphorus aren't the only bi-products of dog poop. DOG WASTE CAN BE FULL OF DISEASE CAUSING BACTERIA AND PARASITES. These are very harmful to humans and spread disease to other dogs. Dog waste is full of E. coli, salmonella and is a common carrier of the following: Worms (several types), Parvovirus, Corona virus, Giardiasis, Salmonellosis, and Cryptosporidiosis. These bacteria and parasites can actually linger in the soil for YEARS. If you don't pick up after your dog, you are putting other people and other dogs at risk of getting sick.

4. It Will Just Wash Away and Be Gone Soon - Not True!

Another common misconception is that if you don't pick it up, it will quickly break down or wash away. DOG WASTE CAN TAKE AS LONG AS A YEAR TO NATURALLY BREAK DOWN. Even if you leave the poop on the ground and it does eventually break down, all of those bacteria and parasites will be left to linger there for several more years.

Be a responsible pet owner and pick up after your dog
