Important information regarding rental properties

Volunteers are in the process of canvassing the neighborhood, obtaining signatures to vote either "IN FAVOR" or vote "AGAINST" amending the "Declaration of Covenants, Conditions and Restrictions" to our HOA Documents.

By now, all homeowners have received a "Written Consent Form" and a copy of "EXHIBIT A", which is the legal wording that will be adopted by the Covenants. In summary, the purpose of this Exhibit is to prohibit rentals of dwellings for an initial 24 months immediately following the date of purchase, or transfer, of a home in The Terraces.

The HOA's goal is to have a determination by the middle of June. The requirement is to have 75% "in favor" vote in order for this to be adopted into the HOA documents. The HOA thanks the volunteers who have helped in this effort.

The POA Board is actively correcting several issues in our community that were deferred by the previous board. Pressure washing of our entrance sign is complete. You will notice new plants and mulch installed on both the front island (Eagle Circle and Red Bug Road) and the 7-11 island.

Clean up of the Lake Sterling entrance will be completed as well as trimming all of the palms to the left as you enter Deer Run. The Board and HOA Representatives are actively working on our waterways with our vendor, AMS. Trash can etiquette

A reminder from The Terraces' Covenants ("Section 18. Refuse") regarding trash containers:

"No trash, garbage, rubbish, debris, waste or materials or other refuse shall be deposited or allowed to accumulate or remain on any Lot. Said containers must be tied or closed at all times and kept from view by the public or residents within the vicinity. Said containers shall not be placed at street-side for removal of refuse prior to the evening before the announced pickup time. Said **containers must be returned to the utility yard or enclosure within eight (8) hours after announced pickup time**."
