Approval of "Leasing Prohibition & Restrictions"

Declaration of Covenants, Conditions and Restrictions

Below is a summary from the HOA attorney, Wonsetler & Webner, P.A., 717 North Magnolia Avenue, Orlando, FL, announcing official approval of the **Leasing Restrictions** on properties in The Terraces. It was a close vote, requiring over 70% majority approval from all homeowners. This document (EXHIBIT A), is now an official addition to The Terraces "Declaration of Covenants, Conditions and Restrictions".

From Attorney Wonsetler & Webner, P.A.:

Our firm has the privilege of representing Deer Run Homeowners Association #7, Inc. As many of you know, the Association by membership vote recently passed an amendment to the rules and regulations governing use of your Lots. A full copy of the amendment was distributed to ALL homeowners ("EXHIBIT A").

SUMMARY: Under the new guidelines, owners must own their home for 24 months prior to leasing the home to any tenants. This amendment discourages absentee investment companies from buying in the community for the sole purpose of turning the home into a short-term rental or rental property. The new rule only applies to owners who purchase after August 8, 2022. Tenants who move in, in violation of the rule, are subject to eviction by the Association.

There is an exception for unforeseen circumstances written into the 24-month prohibition. If an owner purchases a property and an unexpected life event occurs such as the death of a spouse, military deployment, or loss of employment, etc., the owner can appeal to the Board for a waiver of the wait period.

The month of September begins a time when the Board starts preparing next year's budget. Last year's assessment was \$110.00. After reviewing current financial trends, a recommendation will be presented to the Board to NOT increase the HOA assessment for 2023. This will be the second year that the assessment will remain at \$110.00.

Our annual assessment allows the Board to continue regular maintenance of the community property, as well as provide extra activities that make The Terraces an exceptional place to live. The Board is committed to maintaining property values for all property owners.

Also, two important factors in preparing The Terraces' budget:

Property Owners' Association fees
For the year 2022, over 55% of the \$110.00
assessment fee was obligated to the POA
(Property Owners' Association). Generally,
this fee could be increased at their Board's
discretion; however, it will remain at 55%
for 2023.

7 Contingency fund

Maintaining a contingency fund to cover the cost of maintaining the masonry wall along Eagle Circle, bordering The Terraces. Eventually there will be the need for major repairs to the wall, and in some places, replacement. This is caused by uprooting of tree roots growing next to the wall. In 2017, expenses for mold removal, priming and painting of the wall totaled over \$3,000.00. This was very costly, and was not included the budget. A Special Assessment had to be charged homeowners to cover this cost. The current Board has been proactive and prepared for this by including a contingency amount in our budget to sustain most unplanned expenses.



TRASH TALK

MONDAY: Trash & Recycling WEDNESDAY: Yard Debris

THURSDAY: Trash + larger items

Very Large Items (furniture, appliances, lawn equipment, furnaces, bicycles, material from minor household repairs, etc.) collected curbside at no charge by calling *Waste Pro (407) 774-0800*.

Recycling Procedural Change

Seminole County residents should sort recyclables before placing curbside. Seminole County Solid Waste generally offers curbside sorting, but for the safety of collection crews, asks customers to self-sort.

Fibers should be sorted together. *This includes:*

- Pasteboard (i.e., cereal boxes, empty paper towel and toilet paper rolls, pizza boxes)
- Brown paper grocery bags (no wax, no wet strength material, no liners)
- Corrugated cardboard (flattened and cut down to fit inside the recycle bin)
- · Newspaper, supplements, magazines and catalogs
- Box board, carrier stock, white and colored paper
- Telephone Books

Co-mingled containers should be sorted together. *This includes:*

- Plastic Containers #1-7 (#'s on bottom of containers) Remove all lids
- Glass bottles and jars (clear, green and brown)
 -Remove all lids
- · Aluminum cans
- Steel cans and tin household containers, such as food cans

New Holiday Schedule for Trash and Recycle Pickup

If the regular garbage, yard waste or recycling collection day (Monday, Wednesday, or Thursday) falls on a holiday listed below, your collection will be on the next regularly scheduled collection day.

- New Year's Day
- Independence Day
- · Thanksgiving Day
- Christmas Day

Trash containers

A reminder from The Terraces' Covenants ("Section 18. Refuse") regarding trash containers:

When retrieving your receptacles, pick up the few pieces of trash that escape the collectors. Every little bit helps. We can all participate in improving the appearance of our community by doing your part.

Bundle, bag, or can yard debris

Yard debris will **not** get hauled if not bundled, bagged, or canned.
